

RESOLUTION NO 150-17

**A RESOLUTION OF THE WEST MIFFLIN SANITARY
SEWER MUNICIPAL AUTHORITY AMENDING RESOLUTION
NOS.1-96, 13-97, 14-97, AND 92-05**

WHEREAS, the West Mifflin Sanitary Sewer Municipal Authority (Authority) enacted Resolution No. 1-96, which authorized payment of various connection and tap-in fees; and

WHEREAS, the Authority had authorized the preparation of an Act 203 of 1990 study that formed the basis of the tap in fees enacted by the Authority in Resolution No. 13-97;

WHEREAS, the Authority added provisions regarding tap-in approval and fee payment in Resolution 14-97; and

WHEREAS, the Pennsylvania Legislature enacted and the Governor signed Act 57 of 2003 which amended Act 203 of 1990. Act 57 now governs the calculation of tap-in fees; and

WHEREAS, the Authority amended Resolution No. 14-97 to comply with Act 57 of 2003;

WHEREAS, the Authority deems it necessary to amend said Resolution No. 92-05 to ensure maintenance and improvement of the water system; and

NOW, THEREFORE, be it resolved and it is hereby resolved as follows:

FIRST: The Authority hereby acknowledges that beginning in 2014, the total authorized tap-in-fee was set at \$3,400.00 per EDU.

The Authority hereby acknowledges that beginning in 2015, the total authorized tap-in-fee was set at \$3,500.00 per EDU.

The Authority hereby acknowledges that beginning in 2016, the total authorized tap-in-fee was set at \$3,600.00 per EDU.

The Authority hereby acknowledges that beginning in 2017, the total authorized tap-in-fee was set at \$3,700.00 per EDU.

The Authority hereby acknowledges that beginning in 2018, the total authorized tap-in-fee will be set at \$3,800.00 per EDU.

SECOND: The Authority hereby amends Resolution No. 92-05 to include the tap-in-fees provided herein.

THIRD: The Authority hereby ratifies the establishment of the tap-in-fee of \$3,400 consisting of \$1883.60 for the collection portion and \$1516.40 for the capacity portion per EDU in 2014.

The Authority hereby ratifies the establishment of the tap-in-fee of \$3,500 consisting of \$1939.00 for the collection portion and \$1561.00 for the capacity portion per EDU in 2015.

The Authority hereby ratifies the establishment of the tap-in-fee of \$3,600 consisting of \$1994.40 for the collection portion and \$1605.60 for the capacity portion per EDU in 2016.

The Authority hereby ratifies the establishment of the tap-in-fee of \$3,700 consisting of \$2049.80 for the collection portion and \$1650.20 for the capacity portion per EDU in 2017.

The Authority hereby establishes the tap-in-fee of \$3,800 consisting of \$2105.20 for the collection portion and \$1694.80 for the capacity portion per EDU in 2018.

FOURTH: All other provisions of Resolution Nos., 1-96, 13-97, 14-97 AND 92-05 are hereby incorporated by reference with the same force and effect as though fully set forth herein at length.

FIFTH: This Resolution shall take effect on _____.
